However, ARTERIA did not disclose concrete details of the information exchange, etc. in the Securities Registration Statement (as of November 13, 2018) as a risk on the business, etc.

ARTERIA admits the fact that the response to this matter was inadequate, and was considering disciplinary action against the persons involved in order to clarify the responsibility of the management and reorganize the management structure of ARTERIA. ARTERIA's president and CEO also tendered a voluntary resignation, which ARTERIA received today.
